The ornamental design for a video communication system, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a video communication system according to the present invention;
 FIG. 2 is a front view of the video communication system shown in FIG. 1;
 FIG. 3 is a left side view of the video communication system shown in FIG. 1;
 FIG. 4 is a right side view of the video communication system shown in FIG. 1; and,
 FIG. 5 is a bottom view of the video communication system shown in FIG. 1.
